#### The Major Changes Affecting Businesses (as of 2018)

#### The Big 4

- **❖** C Corporations → 21% Flat Tax Rate
  - Was as high as 39%
- ❖ 20% Pass Thru Deduction
  - 199A
- Unlimited Bonus Depreciation
- **❖ NOL Carry Forwards... maxed at 80%**

## Some Other Major Changes Affecting Businesses (as of 2018)

As Time allows...

- Entertainment Deduction Cancelled
- 1031 Exchanges ONLY on Real Property
- Opportunity Zones Created
- DPAD Cancelled
- Property Tax Limitations Only on Sch A
